A Commercial General Liability with limits of \$1,000,000.00 each occurrence and \$2,000,000.00 general and products/completed operations aggregates must be presented upon approval and issuance of a permit from the Village Clerk. Village of Camillus must be listed as an additional insured with ISO endorsement CG 20 26 11 85 or equivalent.
15. The applicant does hereby covenant and agree to defend, indemnify and hold harmless the

Village of Camillus from and against any and all liability, loss, damages, claims, or actions (including costs and attorneys fees) for bodily injury and/or property damage, to the extent permissible by law, arising out of or in connection with the canvassing, soliciting, peddling, or related activities within the Village of Camillus.
